

NIESR Corporate Membership Terms and Conditions

- 1. These terms and conditions, dated March 2024 (these "T&Cs"), are those under which the Licensee has agreed to become a Corporate Member of the National Institute of Economic and Social Research, a UK Registered Charity (Registration Number 306083) and Company Limited by Guarantee (Registration Number 00341010), whose current address is 2 Dean Trench Street, Smith Square, London SW1P 3HE (NIESR).
- 2. The period and date commencement of membership will be as detailed in the licence agreement. The period may be extended by agreement of both parties.
- 3. In respect of membership, the Licensee shall pay an annual membership fee at the rate determined in the licence agreement (plus any applicable VAT). Payment will be made within 30 days of an invoice from NIESR.
- 4. The annual membership fee is quoted on an annual basis and subject to increase in line with inflation.

7. Unless notified otherwise, the Licensee may cite NIESR work provided as part of this Agreement in its publications and other materials, provided that appropriate credit and citation is given. Whilst NIESR will use best endeavours to ensure the quality and appropriateness of the opinions and information provided, it shall have no liability for the accuracy or otherwise of such information, or its appropriateness to any specific context.

8. NIESR will at all times seek to ensure that staff engaged with the Licensee under these terms have appropriate standing and expertise but cannot guarantee the availability of any specific staff member for any specific event.

9. In the event that NIESR is unable to provide the service above to any material extent, or the needs of the Licensee should increase materially, the parties will meet to review the Membership, with a view to changing the level of service or cost involved for the remainder of the period.

10. Subject to the clauses above, all exchanges between the Licensee and NIESR under this agreement shall remain private and confidential to the parties concerned.
